- **Residency:** Please contact the Tuition Grants Commission at <u>info@sctuitiongrants.org</u> to explain your residency situation. Required documentation may differ depending on your situation.
- **Spring-Only Grant:** A detailed letter explaining the reason for your inability to enroll during the fall semester. Please include sufficient documentation to support your request.
- **Late Application:** A detailed letter explaining the extenuating circumstance which prevented you from submitting your FAFSA during the SC Tuition Grants application period of December 31 June 30. Please include sufficient documentation to support your request.
- **Reduced Course-load based on approved ADA Accommodations:** Per State Statute, SC Tuition Grants recipients are required to be enrolled full-time; the only exception to this State law is approved accommodations based on special circumstances under the American with Disabilities Act (ADA) as documented through the office at the College/University which handles such requests. A letter from the respective office, detailing the number of credit-hours needed for the student to be considered "full-time" per semester, is required. An updated letter is required annually.
- <u>5th-Year Grant:</u> A letter requesting an exception to the 8-semester Maximum Grant policy, a copy of all college transcripts, and a letter from your Academic Advisor confirming you are on track to graduate within one or two additional semesters and include your anticipated graduation date. You must enroll full-time (12 or more credit hours) and meet all other eligibility requirements.
- **<u>All other appeal requests:</u>** Please contact the Commission regarding your situation so the correct documentation needed to consider your request can be requested.

PLEASE ALLOW 2-4 WEEKS FOR REVIEW. COMMISSION STAFF WILL BE IN TOUCH IF ADDITIONAL INFORMATION IS REQUIRED TO COMPLETE REVIEW OF YOUR REQUEST
